I will NOT knowingly collect, use, or distribute personal information from children under the age of 13 without prior verifiable consent from a parent or guardian. The only information I collect are email addresses for the purposes of sending out a newsletter.

In collecting the emails, I request a parent's email for those under 13. A parent's email is only used to notify parents and obtain consent, and will not be used for any other purpose.

## **Notice to Parents/Guardians**

Arlenewilliamsbooks.com complies with the requirements of the Children's Online Privacy and Protection Act (COPPA). This notice describes my practice for collecting, using, and disclosing personal information from and about children under the age of 13. # **Revoking Consent and Deleting Information**

I will not disclose your child's information to any other third party without your authorization, except as may be required by law.

# **Section 2: General Privacy Policy**

## What I collect

I may collect the following information:

- email address
- other information relevant to customer surveys and/or book giveaways
- website traffic information through cookies from Google Analytics

## **Surveys & Contests**

<u>From time to time</u>, I may offer surveys and contests, and my site will request information via the surveys or contests. Participation in these surveys or book giveaways is completely voluntary and you may choose whether or not to participate and therefore disclose this information. Information requested may include contact

information (such as name and shipping address), and demographic information (such as zip code, age level). Contact information will be used to notify the winners and award prizes. Survey information will be used for purposes of monitoring or improving the use and satisfaction of this site.

# What I do with the information I gather

If I do collect information via surveys, newsletters, or contests, I will use this information to understand your needs and provide you with a better service, and in particular for the following reasons:

- Internal record keeping.
- I may use the information to improve our products and services.
- I may periodically send promotional email, posts, or newsletters about new products, special offers or other information which I think you may find interesting using the email address which you have provided.
- I may use the information to customize the website according to your interests.
- I will never sell your information.

## Security

We are committed to ensuring that your information is secure. In order to prevent unauthorized access or disclosure I have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information I collect online.

## How I use cookies

A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added and the cookie helps analyze web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences.

This site uses Google Analytics to track visits. Google Analytics logs cookies to identify which pages are being used. This helps me analyze data about web page traffic and improve my website in order to tailor it to customer needs. I only use this information for statistical analysis purposes and then the data is removed from the system.

Overall, cookies help me provide you with a better website, by enabling me to monitor which pages you find useful and which you do not. A cookie in no way gives me access to your computer or any information about you, other than the data you choose to share with me.

You can choose to accept or decline cookies. Most web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. This may prevent you from taking full advantage of the website.

Some of my business partners may use cookies on my site (for example, Google Analytics). However, I have no access to or control over these cookies.

## Links to other websites
